

A Message From Mayor Ronald M. Serpico *Our Famous Feast's History ... Celebrating 124 Years!*

Dear Neighbors,

I can't believe that in all the years I have been writing *The Rose* letter, I have yet to include a story about the one thing that has put Melrose Park on the map and set our little village apart from all the other Chicago suburbs. Of course, I am talking about none other than our Feast of Our Lady of Mount Carmel. And so, relying on historical archives, I now present a cliff note version of our famous Feast's history, which is the longest running religious festival in the Chicago area.

In 1894, ladies from Laurenzana, Provincia Potenza, Italy, founded the Societa Di Signore Italiane Di Maria Santissima Del Carmine. Their leader was Mrs. Emanuella DeStefano, whose husband was seriously ill at the time. Emanuella made a pledge to the Madonna that if her husband was returned to good health she and the members of the Societa would establish the Feast of Our Lady of Mount Carmel in Melrose Park.

Mr. DeStefano's health was restored, and the first Feast was held on the DeStefano farm at 25th and North avenues on July 16, 1894, when Melrose Park was just 12 years old. Hundreds of newly arrived Italians came to the first Feast to honor the statue of Our Lady, which Emanuella had commissioned from a Neapolitan artist. It is a replica of the famous statue of Our Lady of Mount Carmel, venerated for centuries in Laurenzana.

In 1895 a wooden chapel was built on 24th Avenue to house the statue and offer a place of worship for the local Italian community. In September of 1905, Father Benjamin Franch arrived in Melrose Park. He founded the Congregazione Parrocchiale Maria SS Del Monte Carmelo with the intention of getting this group to help him finance and build a new church. But this was not their only task, they were also

asked to help prepare the Feast – thus, becoming the proto-type of what would eventually become the official Feast Committee. In 1907, the chapel was moved to 1101 N. 23rd Ave., and in 1908, a much larger and more beautiful church was built for the burgeoning number of Festa devotees.

From that point on the Feast began developing its own traditions, some of which are still practiced today. On Thursday eve as devotees exited Novena, a marching band would serenade the Virgin and then the band would march through the streets of the parish. On Saturday evening, the band would repeat the ritual, but would also add a concert. It didn't take long before out-of-towners started arriving and camping out on the lawns of homes along the procession route so they too could be part of the celebration.

The procession would start with fireworks saluting the Madonna's exit from church after Solemn High Mass. From there Our Lady was carried on a platform adorned with an arch of flowers and trailed by a satin embroidered canopy. In 1926, this was all changed when Fr. Franch hired an Italian woodcarver to reproduce an elegant Baldachino, which is still used today. What never changed were the crowds of people who would march behind the statue of Mary, praying and singing in thanksgiving or supplication. In the evening there would be a band concert, the crowning of the Queen of the Festa and a magnificent show of fireworks that would bring the Feast to a close.

Despite its Italian origin, other ethnic groups have also been involved in the Feast. Due to Fr. Franch's encouragement, both the St. John Baptist and the St. Anne Lithuanian Societies have marched in the procession. As have the San Rocco and the San Michele Societies, with the San Michele Society carrying a statue of their patron, St. Michael the Archangel, at the lead of the procession for years. And today, Hispanic residents are deeply involved in the Feast and are represented in the procession by Our Lady of Guadalupe and the Grupo San Lucas Societies.

In 1921, the first official Feast Committee met. By 1925, the growing number of groups marching created a need for a grand marshall to organize the procession. Sebastian Lorenzo became grand marshall in 1930 and served 40 years.

Since 1925, decorative, illuminated arches have been set up over 23rd Avenue from Lake Street to Cortez Street. The committee at that time also decided to serve refreshments and have amusements for the children.

In 1922, the Madire Christiane was originated for the mothers of the parish and they marched in the procession until 1960 when they merged with Our Lady of the Sacred Heart Sodality, who had been marching since their founding in 1936. Together they formed the Altar and Rosary Society. Melrose Park followers of St. Anthony of Padua began marching in 1956.

When World War II began, area Italians flocked to the feet of Our Lady to pray for the safe return of their sons and the end of the war. Thousands marched behind the Virgin during these years and many are the stories of prayers answered through her intercession.

In 1944, the Golden Jubilee of the Feast was celebrated and new crowns were purchased for the statue. Because of the large crowd expected, an outdoor altar was constructed near 25th and Augusta; and the first Field Mass was celebrated. The tradition of the outdoor Mass was continued until 1981.

In 1966, a new church was dedicated with a place for Our Lady in a chapel near the entrance. At that point, the Blue Army of Our Lady of Fatima and members of the Italian Catholic Federation began marching in the Feast.

In 1969, in preparation for the 75th anniversary of Our Lady, Fr. Adam Torresan, the pastor at that time, had an Italian jeweler create new crowns for the statue, which were made of 18k gold and bejeweled with precious gems. The crowns were made possible through votive donations made by devotees, who according to custom, would present the statue of Our Lady with a votive offering in gratitude for the favor she had granted. Fr. Adam crowned the statue after the Field Mass that year.

This year the Feast celebrates its 124th anniversary. The dates for this year's Feast are July 13-16. Attend this year's Feast and be part of Melrose Park's grandest tradition.



Dear Melrose Park Police Lt. Rieger...

As per our phone conversation, here is the story of how your police officers, Sullo and Korsch, saved a family of ducklings. Please thank them for me.

Recently, Melrose Park Police officers, Sullo and Korsch, heroically saved a family of ducks from certain death. Under what circumstances the family began their journey from the Winston Plaza parking lot to the forest that lay north of the North Avenue shopping district is unknown.

However, this part of the story begins on a day that seemed to be just like any other day. Or, so I thought, I happened to be doing a quick errand in Winston Plaza. As I got out of my car, I saw a mother duck waddling across the parking lot, with eight tiny ducklings in tow. My first reaction was a feeling of thankfulness for having seen such beautiful creatures.

However, that feeling quickly turned to concern, for she was marching her little ones toward North Avenue and toward an inevitable and catastrophic death. Realizing the danger ahead of them, I walked along with them. As I did so, I tried to coax her into leading her babies in a different direction. But she would have none of it. She knew where she wanted to go and nothing, and no one, was going to prevent her from continuing in this direction.

As we drew nearer to the speeding cars on North Avenue, I wasn't sure where to turn for help. I called a few animal groups, but there was not enough time for them to get there. I then called the Melrose Park Police, begging them to come and help these poor, innocent creatures.

Officers Sullo and Korsch quickly came to the rescue. After having sized up the situation, they stood by their side and watched the family move closer to the street – waiting for the perfect time in which to act. Right before the mother duck jumped into the street, Officer Korsch turned on his lights and slowly drove his car into the eastbound lanes, preventing the cars from moving forward. As the mother duck jumped off the curb and into the street, the babies followed her, tumbling headfirst and rolling down onto the pavement. They quickly got back into line behind their mom and continued waddling to the center medium.

When the mother duck was close to the medium, Officer Korsch moved his car into the westbound lane, again stopping the traffic. Mom easily jumped over the medium, but the babies didn't have the strength to do the same.

Officer Sullo walked into the street and gently picked up each one of the ducklings and placed them on top of the medium. Mom turned and quacked at Officer Sullo, as though she was asking him to hurry up because she had places to go! The ducklings jumped and tumbled down onto the pavement, and again they got to their feet and lined up behind mom. The mother duck and her paddle of ducklings waddled to the curb and jumped up into the soft, safe grass.

As I walked back to my car, I stopped to thank officers Sullo and Korsch for a job well-done. As Officer Sullo put hand sanitizer on his hands, he had a smile on his face and I couldn't help but think that for these two heroic police officers and for this family of ducks, this was a very good day.


NEW FOR 2017


Everyone Has the Right to Live Where They Choose



Beware of Unexpected Checks in the Mail, Scammers Target Anyone

Take a look at the check that Melrose Park PD received in the mail recently. The only problem ... this is a counterfeit check.

How it Works

Scammers send checks in the mail. They usually ask at the time of delivery, or in a follow-up message/letter that you deposit the check into your account, and then send back a portion of the amount via your own check or wire transfer. In this case, the scammer sent the check in a United States Postal Service priority mail envelope.

The Problem Is

The check or money order that you receive and deposit will turn out to be counterfeit. The counterfeit check will be returned to your bank without funds and you will be charged the full amount.

Your Account, Your Responsibility

Any check or money order that you deposit into your bank account is your responsibility. Should the check be returned as unpaid, you will be stuck with the charges. Because of federal law, banks must make deposited money available within one to five business days. This means that it is possible for a person to withdraw funds from their account after unknowingly depositing a counterfeit check. It can sometimes take weeks for a check to be returned to your bank as unpaid. When that happens, the person that deposited the check into their account is responsible for the charges.

What You Should Do


As the saying goes ... "If it seems too good to be true, it likely is." If you receive a check like this in the mail, you should not deposit it. You should shred the check so that it isn't mistakenly deposited later. BEWARE – scammers can be very persistent. If you are contacted via electronic communication, block the scammer. If the scam is on an internet website, report the scammer to the administrator of the site.

Melrose Park Police Offer Safe Disposal Method for Prescription Drugs

The Melrose Park Police Department has partnered with the Cook County Sheriff's Office to offer residents a safe and convenient method for disposing of unused and unwanted prescription medications.

These types of drugs pose a danger within the home. They may become the source of an accidental poisoning or overdose. According to the U.S. Department of Justice, most abused prescription drugs are obtained from friends and family. Disposing of these drugs by throwing them in the trash or flushing them down the toilet may pose health/safety and environmental risks.

In order to provide a preferable alternative for the disposal of these drugs, a secure collection box has been placed in the lobby of the Melrose Park Police Department. "Our residents may now safely dispose of unwanted drugs by simply placing them inside of the collection box in our station," stated Police Chief Sam Pitassi. "This is another way we can assist our residents and promote drug safety within the home," said Pitassi.

The secure collection box is available to residents for unwanted medications 24 hours a day, seven days a week. Please do not place garbage, food, bio-hazardous waste or sharps in the collection box. If you have any questions, you may call the police desk at (708) 344-8409.



The Public Works Employees have been busy preparing for the summer season. All summer equipment is ready to go at a moment's notice. The following are projected projects, ongoing projects and recently completed projects.

20th & Lake Street


No construction or alteration activities shall be carried on between the nighttime hours of 7 p.m. and 7 a.m. on Monday, Tuesday, Wednesday, Thursday or Friday. On Saturday, no construction or alteration activities shall be carried on between the nighttime hours of 5 p.m. and 8 a.m. On Sunday and federal holidays, no construction or alteration activities shall be carried on between the nighttime hours of 5 p.m. and 10 a.m. Construction and alteration activities on Sundays and federal holidays shall not be accompanied by loud or annoying noises except in the case of an emergency. Emergency operations necessitating deviation from this section shall not be initiated until special permission is obtained from the director of Public Works. Construction or alteration activities with regard to public improvements and public service utilities, shall be exempt from this section.

Any person violating this section shall be fined not less than fifty dollars (\$50), nor more than seven hundred fifty dollars (\$750), for each offense, and each day's violation of the same shall constitute a separate and distinct offense.


West Nile Virus

The Illinois Department of Public Health (IDPH) has confirmed the first West Nile virus positive bird and mosquito batches reported in Illinois for 2012. Although it is a little earlier in the season than we normally find it, it is not unheard of.

Last year 19 counties in Illinois reported a West Nile virus positive mosquito batch, bird and/or human case. A total of 34 Illinois residents contracted West Nile virus disease and three died. No human cases of West Nile virus have been reported so far this year.

Surveillance for West Nile virus in Illinois includes laboratory tests on mosquito batches, dead crows, blue jays, robins and other perching birds, as well as testing sick horses and humans with West Nile-like disease symptoms. People who observe a sick or dying crow, blue jay, robin or other perching bird should contact their local health department, which will determine if the bird will be picked up for testing.

West Nile virus is transmitted through the bite of a mosquito that has picked up the virus by feeding on an infected bird. Common West Nile virus symptoms include fever, nausea, headache and muscle aches. Symptoms may last from a few days to a few weeks. However, four out of five people infected with West Nile virus will not show any symptoms. In rare cases, severe illness including meningitis or encephalitis, or even death, can occur. People older than 50 are at higher risk for severe illness from West Nile Virus.



Five Common Myths About West Nile Virus

Myth #1: There's not much I can do about West Nile virus.

Truth: There is a lot that you, personally, can do to reduce your chance of West Nile virus infection.

- Reduce the number of mosquito bites you get. Make a habit of using insect repellent with DEET when outdoors. Spray repellent on exposed skin and clothing. Prime mosquito-biting hours are usually dusk to dawn. Pay special attention to protection during these hours, or avoid being outdoors.
- You can reduce the number of mosquitoes around your home. Mosquitoes breed in standing water, so check your yard once a week: get

rid of containers that aren't being used, empty water from flower pots, change water in bird baths and maintain clean gutters.

- Make sure window and door screens are in good condition. Have an older neighbor or family member? See if they need help installing or repairing screens.

Myth #2: Kids are at the most danger of getting sick from West Nile virus.

Truth: People over 50 are at the highest risk for developing severe West Nile disease.

- Relatively few children have been reported with severe West Nile Virus disease. By contrast, most of the deaths due to WNV during 2002 were among people over 50 years old. Half of those deaths were among people over 77 years old.

• It is always a good idea for children to avoid mosquito bites, but it's also important for adults – especially older adults – to take steps to avoid mosquito bites.

Myth #3: It's only people who are already in poor health who have to worry about West Nile virus.

Truth: Healthy, active older adults who spend time working and exercising outdoors have been affected by severe West Nile virus infection.

- Being over 50 is a risk factor for developing severe West Nile disease if infected with the virus. There is a risk of getting mosquito bites while leading an active life outdoors. This doesn't mean you have to stay inside – it does mean that it's important to use repellent when you go outside.

Myth #4: Repellents containing DEET are not safe.

Truth: Repellents containing DEET are very safe when used according to directions.

- Because DEET is so widely used, a great deal of testing has been done. When manufacturers seek registration with the US Environmental Protection Agency (EPA) for products such as DEET, laboratory testing regarding both short-term and long-term health effects must be carried out.

• There are products with different strengths (percentage of DEET) available. The longer the protection you need the higher percent of DEET needed.

- Repellent with DEET can be used for both adults and children, according to directions

Myth #5: As long as my area has a mosquito control program, I don't have to worry about using repellent.

Truth: Mosquito control activities don't eliminate every mosquito, so personal protection is still important.

- Public activities, such as using products to kill mosquito larvae and adult mosquitoes, are one part of control. Personal protection, such as using repellent, keeping window screens in good condition, and control of household breeding sites are other important steps.

• Collaboration between the community, the family and the individual is needed to achieve the best prevention of West Nile virus infection.

West Nile Virus Facts

What is West Nile Virus?

West Nile virus (WNV) is a potentially serious illness. Experts believe WNV is established as a seasonal epidemic in North America that flares up in the summer and continues into the fall. This fact sheet contains important information that can help you recognize and prevent West Nile virus.

What Can I do to Prevent WNV?

The easiest and best way to avoid WNV is to prevent mosquito bites.

- When you are outdoors, use insect repellents containing an EPA-registered insect repellent. Follow the directions on the package.
- Many mosquitoes are most active at dusk and dawn. Be sure to use

insect repellent and wear long sleeves and pants at these times or consider staying indoors during these hours.

- Make sure you have good screens on your windows and doors to keep mosquitoes out.
- Get rid of mosquito breeding sites by emptying standing water from flower pots, buckets and barrels. Change the water in pet dishes and replace the water in bird baths weekly. Drill holes in tire swings so water drains out. Keep children's wading pools empty and on their sides when they aren't being used.

What Are the Symptoms of WNV?

- **Serious Symptoms in a Few People** – About one in 150 people infected with WNV will develop severe illness. The severe symptoms can include high fever, headache, neck stiffness, stupor, disorientation, coma, tremors, convulsions, muscle weakness, vision loss, numbness and paralysis. These symptoms may last several weeks, and neurological effects may be permanent.

- **Milder Symptoms in Some People** – Up to 20 percent of the people who become infected will display symptoms which can include fever, headache, and body aches, nausea, vomiting, and sometimes swollen lymph glands or a skin rash on the chest, stomach and back. Symptoms can last for as short as a few days, though even healthy people have been sick for several weeks.

- **No Symptoms in Most People** – Approximately 80 percent of people (about four out of five) who are infected with WNV will not show any symptoms at all, but there is no way to know in advance if you will develop an illness or not.

How Does West Nile Virus Spread?

- **Infected Mosquitoes** – Most often, WNV is spread by the bite of an infected mosquito. Mosquitoes become infected when they feed on infected birds. Infected mosquitoes can then spread WNV to humans and other animals when they bite.

- **Transfusions, Transplants and Mother-to-Child** – In a very small number of cases, WNV also has been spread through blood transfusions, organ transplants, breastfeeding and even during pregnancy from mother to baby.

- **Not through touching.** WNV is not spread through casual contact such as touching or kissing a person with the virus.

How Soon Do Infected People Get Sick?

People typically develop symptoms between three and 14 days after they are bitten by the infected mosquito.

How Is WNV Infection Treated?

There is no specific treatment for WNV infection. In cases with milder symptoms, people experience symptoms such as fever and aches that pass on their own, although illness may last weeks to months even in healthy persons. In more severe cases, people usually need to go to the hospital where they can receive supportive treatment including intravenous fluids, help with breathing, and nursing care.

What Should I Do if I Think I Have WNV?

Milder WNV illness improves on its own, and people do not necessarily need to seek medical attention for this infection though they may choose to do so. If you develop symptoms of severe WNV illness, such as unusually severe headaches or confusion, seek medical attention immediately. Severe WNV illness usually requires hospitalization. Pregnant women and nursing mothers are encouraged to talk to their doctor if they develop symptoms that could be WNV.

What is the Risk of Getting Sick from WNV?

- **People Over 50 at Higher Risk to Get Severe Illness** – People over the age of 50 are more likely to develop serious symptoms of WNV if they do

get sick and should take special care to avoid mosquito bites.

- **Being Outside Means You're at Risk** – The more time you're outdoors, the more time you could be bitten by an infected mosquito. Pay attention to avoid mosquito bites if you spend a lot of time outside, either working or playing.

- **Risk Through Medical Procedures is Very Low** – All donated blood is checked for WNV before being used. The risk of getting WNV through blood transfusions and organ transplants is very small, and should not prevent people who need surgery from having it. If you have concerns, talk to your doctor.

- **Pregnancy and Nursing do not Increase Risk of Becoming Infected with WNV** – The risk that WNV may present to a fetus or an infant infected through breastmilk is still being evaluated. Talk with your care provider if you have concerns.

What is the CDC Doing About WNV?

CDC is working with state and local health departments, the Food and Drug Administration and other government agencies, as well as private industry, to prepare for and prevent new cases of WNV. Some things CDC is doing include:

- Coordinating a nationwide electronic database where states share information about WNV.

- Helping states develop and carry out improved mosquito prevention and control programs.

- Developing better, faster tests to detect and diagnose WNV.

- Creating new education tools and programs for the media, the public, and health professionals.

- Opening new testing laboratories for WNV.

- Working with partners to develop vaccines.

What Else Should I Know?

If you find a dead bird don't handle the body with your bare hands. Contact the Health Department at (708) 343-4000, for instructions on reporting and disposing of the body. They may tell you to dispose of the bird after they log your report.

About the Zika Virus Disease

Zika virus disease (Zika) is a disease caused by the Zika virus, which is spread to people primarily through the bite of an infected *Aedes* species mosquito. The most common symptoms of Zika are fever, rash, joint pain, and conjunctivitis (red eyes). The illness is usually mild with symptoms lasting for several days to a week after being bitten by an infected mosquito. People usually don't get sick enough to go to the hospital and they very rarely die of Zika. For this reason, many people might not realize they have been infected. However, Zika virus infection during pregnancy can cause a serious birth defect called microcephaly (<http://www.cdc.gov/ncbddd/birthdefects/microcephaly.html>), as well as other severe fetal brain defects. Once a person has been infected, he or she is likely to be protected from future infections.

Zika virus was first discovered in 1947 and is named after the Zika Forest in Uganda. In 1952, the first human cases of Zika were detected and since then, outbreaks of Zika have been reported in tropical Africa, Southeast Asia and the Pacific Islands. Zika outbreaks have probably occurred in many locations. Before 2007, at least 14 cases of Zika had been documented, although other cases were likely to have occurred and were not reported. Because the symptoms of Zika are similar to those of many other diseases, many cases may not have been recognized.

In May 2015, the Pan American Health Organization (PAHO) issued an alert regarding the first confirmed Zika virus infection in Brazil. On Feb. 1, 2016, the World Health Organization (WHO) declared Zika virus a Public Health Emergency of International Concern (PHEIC). Local transmission has been reported in many other countries and territories. Zika virus will likely continue to spread to new areas.

Specific areas where Zika is spreading (<http://www.cdc.gov/zika/geo/index.html>) are often difficult to determine and are likely to change over time. If traveling, please visit the CDC Travelers' Health site for the most updated travel information.

What We Know

- No vaccine exists to prevent Zika virus disease (Zika).
- Prevent Zika by avoiding mosquito bites.
- Mosquitoes that spread Zika virus bite mostly during the daytime.
- Mosquitoes that spread Zika virus also spread dengue and chikungunya viruses.

Steps to Prevent Mosquito Bites

When in areas with Zika and other diseases spread by mosquitoes, take the following steps:

- Wear long-sleeved shirts and long pants.
- Stay in places with air conditioning, and window and door screens to keep mosquitoes outside.
- Take steps to control mosquitoes inside and outside your home (<http://www.cdc.gov/zika/prevention/controlling-mosquitoes-at-home.html>).
- Sleep under a mosquito bed net if you are overseas or outside and are not able to protect yourself from mosquito bites.
- Use Environmental Protection Agency (EPA)-registered insect repellents with one of the following active ingredients – DEET, picaridin, IR3535, oil of lemon eucalyptus or para-menthane-diol. Choosing an EPA-registered repellent ensures the EPA has evaluated the product for effectiveness. When used as directed, EPA-registered insect repellents are proven safe and effective, even for pregnant and breast-feeding women.
 - Always follow the product label instructions.
 - Reapply insect repellent as directed.
 - Do not spray repellent on the skin under clothing.
 - If you are also using sunscreen, apply sunscreen before applying insect repellent.

To Protect Your Child from Mosquito Bites

- Do not use insect repellent on babies younger than 2 months old.
- Do not use products containing oil of lemon eucalyptus or para-menthane-diol on children younger than 3 years old.
- Dress your child in clothing that covers arms and legs.
- Cover crib, stroller and baby carrier with mosquito netting.
- Do not apply insect repellent onto a child's hands, eyes, mouth and cut or irritated skin.
- Adults – spray insect repellent onto your hands and then apply to a child's face.
- Treat clothing and gear with permethrin or purchase permethrin-treated items.
- Treated clothing remains protective after multiple washings. See product information to learn how long the protection will last.
- If treating items yourself, follow the product instructions carefully.
- Do not use permethrin products directly on skin. They are intended to treat clothing.

Even if they do not feel sick, travelers returning to the United States from an area with Zika should take steps to prevent mosquito bites for three weeks so they do not spread Zika to mosquitoes that could spread the virus to other people.

Symptoms

Most people infected with Zika virus won't even know they have the disease because they won't have symptoms. The most common symptoms of Zika are fever, rash, joint pain or conjunctivitis (red eyes). Other common symptoms include muscle pain and headache. The incubation period (the time from exposure to symptoms) for Zika virus disease is not known, but is likely to be a few days to a week.

See your doctor or other healthcare provider if you are pregnant and develop a fever, rash, joint pain or red eyes within two weeks after traveling to a place where Zika has been reported. Be sure to tell your doctor or other healthcare provider where you traveled.

The illness is usually mild with symptoms lasting for several days to a week.

People usually don't get sick enough to go to the hospital and they very rarely die of Zika. For this reason, many people might not realize they have been infected.

Zika virus usually remains in the blood of an infected person for about a week but it can be found longer in some people.

Once a person has been infected, he or she is likely to be protected from future infections.

Diagnosis

The symptoms of Zika are similar to those of dengue and chikungunya diseases spread through the same mosquitoes that transmit Zika.

See your doctor or other healthcare provider if you develop the symptoms described above and have visited an area where Zika is found.

If you have recently traveled, tell your doctor or other healthcare provider when and where you traveled.

Your doctor or other healthcare provider may order blood tests to look for Zika or other similar viruses like dengue or chikungunya.

Treatment

There is no vaccine to prevent or medicine to treat Zika virus.

Treat the symptoms:

- Get plenty of rest.
- Drink fluids to prevent dehydration.
- Take medicine such as acetaminophen (Tylenol®) or paracetamol to reduce fever and pain.
- Do not take aspirin and other non-steroidal anti-inflammatory drugs (NSAIDs) until dengue can be ruled out to reduce the risk of bleeding.
- If you are taking medicine for another medical condition, talk to your doctor or other healthcare provider before taking additional medication.

If you have Zika, prevent mosquito bites (<http://www.cdc.gov/zika/prevention/index.html>) for the first week of your illness.

- During the first week of infection, Zika virus can be found in the blood and passed from an infected person to a mosquito through mosquito bites.
- An infected mosquito can then spread the virus to other people.

Know Your Risk When Severe Weather Occurs

Being prepared means learning about summer weather and water hazards such as hurricanes, heat, lightning, rip currents, air quality, tsunamis and wildfires.

Here's what you need to know:

- Since 2003, 43 states within the continental United States have come under a tornado watch; 49 states have come under severe thunderstorm watches; and lightning strikes occur in every state.
- Heat waves are common across the country during the summer. They are dangerous because the human body cannot cool itself properly when exposed to an extreme combination of heat and humidity.
- In 2015, there were 26 lightning fatalities.
- Flash flooding is the number one killer associated with severe weather.
- Air pollution can make it harder for people with asthma and other respiratory diseases to breathe. Children and teens may be more sensitive than adults to the health effects caused by air pollution. According to the EPA, poor air quality is responsible in the U.S. for an estimated 60,000 premature deaths each year.

Take Action

While the weather may be wild, you are not powerless. This summer, prepare for hazards with these simple steps:

- You may have only minutes to find shelter before a tornado strikes. Practice a family tornado drill at least once a year.
- Protect yourself from extreme heat by rescheduling outdoor activities to earlier in the day.
- There is no safe place outside when lightning is in the area. If you hear thunder, you are likely within striking distance of the storm. Just remember, When Thunder Roars, Go Indoors.
- Whether on foot or in a car, if you encounter flood waters, Turn Around Don't Drown!
- Make sure to check the Air Quality Index for your area at <http://airnow.gov>. If the air quality is poor, avoid prolonged or extreme exertion outdoors.

Policies and Procedures


Only one reservation per rider per day. NO EXCEPTIONS!



Garage Sale Notice

The rules on garage sales held in the village of Melrose Park are as follows:

Garage sales will be held on the third weekend only during the months of May, June, July, August and September. Sales are to be conducted on Thursday, Friday and Saturday of the designated weekends. No sales are allowed on Sundays.

The dates for 2017 are July 20-22, Aug. 17-19 and Sept. 14-16.

Garage sales shall be conducted only during the hours of 9 a.m.-5 p.m.

No permit is needed for garage sales, however the following rules must be followed:

- No garage sales may be conducted in apartment buildings.
- No garage sales in the frontyard, i.e. on the grass.
- All garage sales to be conducted in backyard, garage or driveway.
- All sale items to be displayed on tables not on the ground.
- No sale items shall be located and no sale activity shall be conducted in the frontyard area on the premises of any public sidewalk, parkway area or other public property.
- No sale signs, handbills or other advertising material shall be located or posted upon public parkway or on public property, signs, poles or light poles within the village of Melrose Park.
- Signs advertising the sales shall not exceed 3-by-5 feet and may be located only in the frontyard (private property) of the address having the garage sale and must be removed immediately after the sale.
- The sale will be conducted without the use of outdoor loud speakers, amplification equipment or illuminated advertising devices.

Any person violating these rules shall be subject to a fine not to exceed \$500.

A copy of the garage sale rules is available at the Village Hall.

Dear Friends,

For the third year in a row, Illinois' spring legislative session has come to an end without a balanced budget. At a recent House Appropriations-Human Services Committee hearing, I witnessed hours of heartbreaking testimony from survivors of domestic violence, parents of children with severe disabilities and breast cancer patients who have lost the vital state services they rely on to survive. Too many of our neighbors will continue to suffer unless Gov. Rauner comes to the table and negotiates a budget.

Despite this ongoing crisis, there has been progress made in Springfield.

- Earlier this year, I passed legislation that will allow emergency medical service technicians to administer vital medication to their patients, saving thousands of lives that could otherwise have been lost in route to the hospital.
- Families across the state will be safer under the Smoke Detector Act, an initiative I introduced to ensure the smoke detectors in our homes are of the highest quality.
- Under a measure I introduced, prospective college students will receive college credit for previous work experience or job training programs they've participated in. This will make it easier and more affordable for working people to pursue a degree.
- I have continued negotiating with my colleagues across the aisle to pass my bill that would place important safeguards on gun dealers that have the potential to drastically reduce illegal gun trafficking in Illinois.

I remain a strong supporter of policies that will lift up the middle class, including this year's initiatives to raise the minimum wage, protect individuals with preexisting conditions from losing access to health insurance and to stop large corporations from taking advantage of tax breaks before shipping local jobs out of state. Families, veterans and seniors would finally receive relief from our outrageous property taxes under legislation passed through the House this year.

The budget remains my number one legislative priority as the General Assembly proceeds into continuous session. The House Democratic Caucus stands ready as always to negotiate for the benefit of working families and our state's most vulnerable residents. I compel Gov. Rauner to look beyond his misguided Turnaround Agenda and finally begin working for true reform that will lift up Illinois.

Willis Passes Controls on Health Insurance Rates, Protections for People with Preexisting Conditions

As Washington politicians push for reckless changes to a federal law which would strip insurance from people with preexisting conditions and increase premiums, state Rep. Kathleen Willis, D-Addison, is fighting to stop massive insurance companies from gouging middle-class families and ensure no one can be denied care because of their medical history.

“Our neighbors deserve access to healthcare regardless of any preexisting medical condition,” said Willis. “Denying people, from cancer patients to kids with disabilities, from the treatments and procedures they need to be healthy would be devastating to millions of families throughout the state.”

Willis sponsored and voted to pass House Bill 2624, which creates an independent Health Insurance Rate Review Board to review and approve proposed insurance premiums and block unjustified increases intended only to increase corporate profits at the expense of consumers.

Additionally, Willis passed state-level protections for people with preexisting conditions like cancer, diabetes or heart disease. While Washington politicians continue fighting to repeal federal protections for these at-risk individuals, Willis’ House Bill 2959 would prevent insurance companies selling policies in Illinois from discriminating against the sickest, oldest and most in need of care. The legislation passed the House with bipartisan support.

“Families in our community would be protected from Washington’s disastrous healthcare policies under these measures,” said Willis. “The healthcare needs of working people, seniors and children must be prioritized over the profits of large insurance companies.”

Willis Passes Legislation Out of House to Protect First Responders

Firefighters and emergency medical service personnel face dangerous situations every day in their line of duty, but legislation passed out of the House recently by state Rep. Kathleen Willis, D-Addison, would encourage property owners to ensure their buildings are safe for first responders in case of an emergency.

“When a property owner creates a dangerous condition in a building or allows code violations to go unresolved, this is not just irresponsible – it’s potentially life-threatening to first responders should a fire or medical emergency occur,” Willis said. “Anyone who tries to cover up dangerous structural issues rather than fix them must face the consequences if their actions result in the death or injury of a first responder.”

House Bill 531, the Daniel Capuano Memorial Act, was created in reaction to the tragic death of firefighter Dan Capuano as he was responding to a fire in a vacant Chicago warehouse. The owners of the building failed to

install adequate protections in the structure while renovations were occurring. This oversight ultimately resulted in Capuano falling two stories through an open elevator shaft. Under Willis’ legislation, this action would result in a Class Four felony charge.

“First responders and their loved ones know that life-threatening situations can occur at any time – as the wife of a retired firefighter, I remember this anxiety,” Willis said. “We must be doing everything in our power to ensure these brave men and women can come home to families at the end of the day.”

Willis Advocates for Continued Federal Funding for Drug Prevention Programs

As deadly drug overdoses continue to rise in the Western suburbs and across Illinois, state Rep. Kathleen Willis, D-Addison, is urging President Trump to continue funding the federal programs that have been vital in helping local law enforcement address this epidemic.

“It’s heartbreaking that so many people – from teenagers to mothers and fathers – lose their lives every day due to drug overdoses. Last year in DuPage County, the number of heroin related deaths more than doubled,” Willis said. “Drug trafficking prevention programs work to put a stop to these terrible addictions before they can even begin by keeping drugs out of our communities and providing the support that people at risk of drug abuse need to stay safe.”

Donald Trump’s proposed budget seeks to cut 95 percent of the Office of National Drug Control Policy’s federal funding for the 2018 fiscal year. The Trump Administration’s budget proposal includes zero dollars for the High Intensity Drug Trafficking Areas Program, which coordinates local, state and national efforts to stop the sales of narcotics. The Drug-Free Communities Support Program, which provides community-based youth substance abuse resources, would receive no federal funding. Willis is a sponsor of House Resolution 384, a measure encouraging President Trump to reconsider funding these vital programs.

“Over 2,300 people lost their lives in Illinois last year as a result of drug use. Without funding for the vital programs that train law enforcement to stop drug trafficking operations, provide substance abuse resources and conduct programming to help young people stay away from deadly narcotics, this crisis is only going to become more tragic,” Willis said. “I urge Donald Trump to stick to his promise to fight the opioid epidemic and fund programs that have been proven to save lives.”

SOURCE WATER (MANDATORY)

VILLAGE OF MELROSE PARK DRINKING WATER SOURCE

Lake Michigan is the surface water supply used to provide drinking water for Chicago and 123 suburban communities. The Environmental Protection Agency (EPA) has found that the quality of Lake Michigan has improved dramatically over the past 21 years. Lake Michigan, by volume, is the second largest Great Lake and the only one located totally within the United States. It serves as a source of drinking water, as a place for swimming and fishing, and as a scenic wonderland. Sources of drinking water used for both tap water and bottled water can pick up contaminants as water travels over the surface of the land or through the ground. The drinking water source is vulnerable to industrial waste and runoff from surrounding lands. Potential sources of pollution such as pesticides, herbicides, radioactive materials, and organic and inorganic petroleum and gas production by-products can impact the source water. We do not have indications of the presence of these contaminants at this time, mainly because of restrictions, which prohibit industrial effluents from entering Lake Michigan, Sewage treatment plant effluents are not discharged into the lake, thereby reducing the threat of microbial contamination. All 63 miles of shoreline within Illinois are now considered to be in good condition. The Illinois EPA Office of Groundwater will be doing a source water assessment within the next three years. When completed, all sources of Pollutants into Lake Michigan will be identified and there will be information regarding the source water's susceptibility to contaminants based on the findings of the assessment. Since the quality of the raw water source is good, conventional treatment methods of disinfection, coagulation and sedimentation, and sand filtration are adequate for producing a water that is free of harmful contaminants.

HOW IS MY WATER TREATED AND PURIFIED?

The City of Chicago Water Department provides the water treatment necessary to safeguard the water delivered to Melrose Park. Water is taken from Lake Michigan at several water inlets located about 3 miles from shore. Chlorine is then injected into the water for disinfection. The water then flows through a series of settling and filtration basins where small amounts of polymer and sedimentation chemicals are added. After this process is complete, the water is filtered to remove the sediment. At this point the water is filtered through layers of fine charcoal and silicate sand. Small particles are removed and pure clean water is ready to be re-chlorinated as a safeguard and precaution against any microorganisms.

VOLUNTARY TESTING (OPTIONAL)

The Chicago Water Department monitors for contaminants which are proposed to be regulated or for which no standards currently exist but which could provide useful information in assessing the quality of the source water or the drinking water.

Cryptosporidium – Analyses have been conducted monthly on the source water since April 1993. Cryptosporidium has not been detected in these samples. Treatment processes have been optimized to ensure that if there are cryptosporidium cysts in the source water, they will be removed during the treatment process. By maintaining a low turbidity and thereby removing the particles from the water, the threat of cryptosporidium organisms getting into the drinking water system is greatly reduced.

Asbestos – Samples are examined for asbestos fibers in the source water and finished water on a routine basis. The EPA has determined that asbestos fibers greater than 10 microns in length could potentially cause lung cancer. We did not find fibers that are in this size category.

Taste and odor compounds – MIB and geosmin are monitored both in the source water and finished water. These analyses assist the personnel to determine the effectiveness of the treatment process as they strive to reduce these compounds and provide a drinking water without detectable tastes and odors.

The City of Chicago carefully monitors the chlorine, using just enough chlorine to protect its customers, without compromising taste. Lastly, fluoride is added to inhibit tooth decay. A corrosive inhibitor is added to protect the distribution system pipes.

The finished water is pumped into the City of Chicago supply system. The water there is pumped westerly by the city's Springfield Pumping Station through a 48"-36" supply line to the Village of Melrose Park's connection at Harlem and Wabansia.

Water is stored in the Village's 2 million gallon reservoir and again pumped by a booster station at 8300 North Avenue. The water travels through a 42" supply line to 2-4 million gallon reservoirs at the 15th Avenue pumping station and a 2 million gallon reservoir at the 23rd Avenue Main Pumping Station. At those points the water is pumped into the local water distribution lines. The Village of Melrose Park once again tests the water for chlorine levels, and adds the required chlorine to insure clean and safe water to its consumers.

SUBSTANCE EXPECTED IN DRINKING WATER

Under The Safe Drinking Water Act. S.D.W.A., the U.S.A. Environmental Protection Agency is responsible for establishing national limits for hundreds of substances in drinking water. The Act also specifies various treatments that water systems must use to remove these substances.

The Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the USEPA's Safe Water Hotline (1-800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the USEPA's Safe Drinking Water Hotline (1-800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village Of Melrose Park is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. IF THERE WERE A PROBLEM WITH WATER CONTAMINANT, WHO WOULD NOTIFY ME?

If contaminant levels were to exceed the M.C.L. for safe use, the Village of Melrose Park Department of Public Works will notify you with newspaper, TV and radio announcements. Also, the Village's Emergency Services/Public Safety would patrol the streets of Melrose Park instructing you of what appropriate action you can use to protect your family's health. These actions might include boiling the water for a particular period of time.

TABULAR INFORMATION

This report includes tables of contaminants found in drinking water. The tables do not list contaminants that were not found in the Chicago and Melrose Park water supply. Any contaminants detected in Melrose Park's water were under maximum contaminants levels (M.C.L.) within the safe drinking water guidelines set by U.S. EPA and are not expected to cause any health risks. However, it is important for you to know exactly what was detected and how much of the substance was present in the water.

The Village of Melrose Park hopes this information helps make its water customers better informed on the water we use in our homes and businesses.

2016 NON-DETECTED CONTAMINANTS

The following table includes contaminants monitored for, but not detected in the most recent sample. The CCR rule does not require that this information be reported; however, monitoring had indicated that these contaminants were not present in the water supply. In compliance with the Unregulated Contaminant Monitoring Rule 3 (UCMR3) as required by the EPA, the City of Chicago has monitored for 28 contaminants suspected to be present in drinking water, but that do not have health-based standards set under the safe drinking Water Act. The monitoring results were reported to the EPA. The list of the UCMR3 contaminants that we have monitored included volatile organic chemicals, metals, perfluorinated compounds, hormones, 1, 4-dioxane and chlorate.

The contaminants that were detected in this monitoring program are listed below.

WATER QUALITY DATA TABLE FOOTNOTES

Turbidity

Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.

Unregulated Contaminants:

A maximum contaminant level (MCL) for this contaminant has not been established by either state or federal regulations, nor has mandatory health effects language. The purpose for monitoring this contaminant is to assist USEPA in determining the occurrence of unregulated contaminants in drinking water, and whether future regulation is warranted.

Fluoride

Fluoride is added to the water supply to help promote strong teeth. The Illinois Department of Public Health recommends an optimal fluoride range of 0.9 mg/l to 1.2 mg/l.

Sodium

There is not a state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials that are concerned about sodium intake due to dietary precautions. If you are on a sodium-restricted diet, you should consult a physician about this level of sodium in the water.

WHAT'S IN MY WATER?

Each year, the Village analyzes hundreds of water samples for bacteria, turbidity, inorganic contaminants, lead and copper, nitrate, volatile organic contaminants, total trihalomethanes, and synthetic organic contaminants. For your information, we have compiled a list in the table below showing what substances were detected in our drinking water.

ug/l: micrograms per litre or parts per billion – or one ounce in 7,350,000 gallons of water.

Na: not applicable.

Avg: Regulatory compliance with some MCLs is based on running annual average of monthly samples.

Maximum Residual Disinfectant Level (MRDL): The highest level of disinfectant allowed in drinking water.

*MCL Statement: The maximum contaminant level (MCL) for TTHM and HAA5 is 80 ppm and 60 ppm respectively and is currently only applicable to surface water supplies that serve 10,000 or more people. These MCLs will become effective 01/01/2005 for all groundwater supplies and surface supplies serving less than 10,000 people. Until 01/01/2005, surface water supplies serving less than 10,000 people, any size water supply that purchase from a surface water source, and groundwater supplies serving more than 10,000 people must meet a state imposed TTHM MCL of 100 ppm. Some people who drink water containing trihalomethanes in excess of the MCL over many years experience problems with their livers, kidneys, or central nervous systems, and may have increased risk of getting cancer.
