**ORDINANCE NO. 1020**

**AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF CERTAIN MOTOR VEHICLES (FOUR SQUAD CARS) FOR THE VILLAGE OF MELROSE PARK, COUNTY OF COOK, STATE OF ILLINOIS.**

**WHEREAS**, the Village of Melrose Park, County of Cook, State of Illinois (the “Village”) is a duly organized and existing village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances for the benefit of the residents of the Village; and

**WHEREAS**, the Village President, the Honorable Ronald M. Serpico (the “President”), the Village Clerk, the Honorable Mary Ann Paolantonio Salemi (the “Clerk”), and the Village Board, namely, the Honorable John S. Conteduca, Cathleen Cossident Italia, Thomas Klein, Ruben Lomeli, Arturo J. Mota and Anthony J. Prignano (the “Village Board”), all having taken office on May 2, 2005, constitute the duly elected, qualified and acting officials of the Village (collectively, the President and Village Board constitute the “Corporate Authorities”); and

**WHEREAS**, the Corporate Authorities deem it advisable and necessary for the operation of the Village and the health, safety, and welfare of its residents to purchase four (4) motor vehicles (collectively “Vehicles” and singularly a “Vehicle”), as further specified herein; and

**WHEREAS**, the Village is authorized to purchase property, including equipment, by contract for public purposes pursuant to 65 ILCS 5/2-3-8; and

**WHEREAS**, Section 3.04.020 of the Village of Melrose Park Municipal Code authorizes the Village to enter into contracts to purchase goods or services under certain circumstances upon the authorization of the Corporate Authorities by a vote of two-thirds of the Village Board; and

**WHEREAS**, the State of Illinois government (the "State"), as a result of its Joint Purchasing Agreement, determines and approves the lowest qualified responsible bidder from the region to be the seller of such equipment; and

**WHEREAS**, the State, and thus, the Corporate Authorities, have hereby determined that Sutton Ford of 21315 Central Avenue, Matteson, Illinois 60443 is the best qualified seller of the Vehicles (the "Seller"); and

**WHEREAS**, the Seller has agreed to sell the Vehicles to the Village for the sales price of Twenty-Two Thousand, One Hundred, Ten and 00/100 Dollars (\$22,110.00) per Vehicle (including all applicable taxes) for a total amount of Eighty-Eight Thousand, Four Hundred, Forty and 00/100 Dollars (\$88,440.00); and

**WHEREAS**, the Village has previously appropriated or allocated from its budget sufficient funds to make the purchase, the funds are readily available, and the Village intends to use the aforementioned funds to complete said purchase; and

**NOW, THEREFORE, BE IT ORDAINED** by the President and the Board of Trustees of the Village of Melrose Park, County of Cook, State of Illinois, as follows:

**ARTICLE I.  
IN GENERAL**

**Section 01. Incorporation Clause.**

All of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct, and the Corporate Authorities do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

**Section 02. Purpose.**

The purpose of this Ordinance is to authorize and direct the purchase of the Vehicles from the Seller in an amount not to exceed Eighty-Eight Thousand, Four Hundred, Forty and 00/100 Dollars (\$88,440.00).

**Section 03. Invocation of Authority.**

This Ordinance is enacted pursuant to the authority granted to the Village by the Constitution of the State of Illinois and the Illinois Compiled Statutes.

**Section 04. State Law Adopted.**

All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Ordinance are hereby incorporated herein by reference.

**ARTICLE II.  
PURCHASE OF MOTOR VEHICLES**

**Section 05. Authorization and Terms of Purchase.**

The Corporate Authorities hereby waive bidding requirements as authorized by Section 3.04.020 of the Code of Ordinances of the Village and authorize and direct the Village to purchase the Vehicles from the Seller in an amount not to exceed Eighty-Eight Thousand, Four Hundred, Forty and 00/100 Dollars (\$88,440.00).

**Section 06. Approval and Execution of Documents.**

The form, terms and provisions of the purchases are hereby approved in substantially the same form as attached hereto and made a part hereof as Exhibit A ("Purchase Orders") with such insertions, omissions and changes as shall be approved by the President and/or the Village Attorney. The President, the Village Comptroller and/or other Village officials as may be required, are hereby authorized and directed to execute and complete the Purchase Orders and any other documents necessary to effectuate the intent of this Ordinance, whether or not such other documents are attached hereto. The Clerk is hereby authorized and directed to attest to and countersign any and all documents that may be necessary to carry out and give effect to the purpose of this Ordinance and affix the seal of the Village to such documents.

**Section 07. Other Actions Authorized.**

The officers and employees of the Village shall take all action necessary or reasonably required to carry out, give effect to the intent of this Ordinance and otherwise to consummate the transactions contemplated hereby and to take all action necessary in conformity therewith, including, without limitation, the execution and delivery of any other documents required to be delivered in connection with the transaction. Any and all actions whether past, present or future, performed by officials and employees of the Village, in connection with carrying out and consummating the transactions contemplated by this Ordinance, are hereby, by this reference, authorized, approved and ratified in all respects.

**ARTICLE III.  
HEADINGS, SAVINGS CLAUSES,  
PUBLICATION, EFFECTIVE DATE**

**Section 08. Headings.**

The headings for the articles, sections, paragraphs and sub-paragraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provisions of this Ordinance.

**Section 09. Severability.**

The provisions of this Ordinance are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section, or part of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision, clause, sentence, paragraph, sub-paragraph, section, or part shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the Corporate Authorities that this Ordinance would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section, or part thereof been included.

**Section 10.00 Superseder.**

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

**Section 11.00 Publication.**

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.
